

Terms of Use for Downloading the Verification Equipment List File

In order to download a **verification equipment list file** ("Subject Matter"), you have to accept all of the following terms of use ("Terms of Use"). The user of this download page is deemed to have accepted this Terms of Use. We may change, make temporarily unavailable, or discontinue the download page of the Subject Matter ("Corner") at any time at our own discretion and without prior notice.

TERMS

(Purpose)

Article 1. This Terms of Use is intended to set forth the terms and condition for using the Subject Matter that the user is required to accept in advance.

(Definition)

Article 2. The following terms used in this Terms of Use have the meanings set forth below.
"User" means a person who downloads the Subject Matter from thee Corner.

(User's responsibility)

Article 3. The User shall use the Corner and the Subject Matter at its own risk and discretion. We will not be liable in any way for any accidents or problems that may occur on the Corner or in connection with the Subject Matter. The User shall use the Corner and the Subject Matter at its own risk and hold us harmless from any problems or damage.

(Copyright etc.)

Article 4. We will remain the owner of the copyright and moral rights regarding the Subject Matter which we provide to the User as well as know-how and other intellectual property rights contained therein.

2.The User shall use and handle the Subject Matter provided to you from us in accordance with the following rules.

- (1) Use the Subject Matter in accordance with the Terms of Use and only for the purpose of **obtaining information about equipment available when using our Collaborate System Verification Center**.
- (2) Do not reproduce, alter, edit, or distribute the Subject Matter.
- (3) Do not lend, assign, or establish security on the Subject Matter to or for a third party, whether for profit or not.
- (4) Do not delete or alter our or our designated person's copyright or trademark notices.

(Prohibited matters)

Article 5. The User shall not do any of the following acts when using the Subject Matter.

- (1) Use the Subject Matter for purposes other than **obtaining information about equipment available when using our Collaborate System Verification Center**.
- (2) Do anything that is violate or is suspected to be violate laws and regulations or public order and morals.
- (3) Reproduce, process, disassemble, analyze, or reverse-engineer the Subject Matter.

2. If the User has done or appears likely to do any of the prohibited acts listed in the Article 5.1, we may immediately stop its use of the Subject Matter without prior notice, and the User is required to cease its use of the Subject Matter accordingly.

(User's equipment etc.)

Article 6. The User shall prepare, at its own expense, all equipment and the likeneccessary for it to

be able to use the Subject Matter. The User will take required procedures and shall be completed on the User's own responsibility, and all expenses related to such use, including, but not limited to, communication expenses, shall be borne by the User.

(Disclaimer)

Article 7. We will not be liable in any way for any damage that may be caused to the User or other third parties as a result of its use of the Subject Matter.

2. We will not be liable in any way for any damage that may be caused to the User or other third parties as a result of the suspension, discontinuation, or stoppage of or restriction of access to this Corner, or failures in communication lines, or otherwise.

(Revision of the Terms of Use)

Article 8. We may change this Terms of Use at any time without any procedure, including, but not limited to, prior notification for acceptance, and concurrently with any such change, the new version of these Terms of Use shall become applicable.

(Governing law and jurisdiction)

Article 9. The Terms of Use shall be governed by the laws of Japan.

2. With regard to any arbitration that may arise between us and the User in connection with the use of the Subject Matter, the Osaka District Court shall be the agreed court of exclusive jurisdiction in the first instance.

Supplementary provisions

These Terms of Use shall become effective on **July 17, 2017**.
